# **Intermodal Fleet Privacy Policy**

At STG Logistics, we recognize and respect your privacy. We understand that you want to control your personal information and that is why we limit the information we collect from you over the Internet to what is needed for conducting business and offering products and services that might be of interest to you. By accessing and using our site, you agree that we may collect and use your information on the terms and conditions set forth in our Privacy Policy below.

## Responsibility

To help protect against unauthorized disclosure of the information you share with us, we limit access to our customer files to only those employees with a need to know. All personally identifiable customer information is transmitted via a secure connection and maintained on a secure server that is administered for us by a service provider. Our service providers have agreed not to disclose to third parties confidential information received from STG Logistics except to their employees and contractors who need to know such information to carry out their responsibilities. Each service provider is required to inform such third parties of the existence and requirements of this confidentiality obligation.

## Use of Personally Identifiable Information

From time to time we may provide information about you to a business partner in order to inform you of products and services which may be of interest to you. We may also directly send you mailings. You may request that we not share your information with our business partners or send you mailings by e-mailing us to that effect or calling us (see below). You agree that we may use your personal information given to us for on-line processing purposes to ensure the proper completion of each order and, as necessary, location information from your mobile device when using STG Intermodal Fleet. We will also disclose your personally identifiable information to third parties if we are required to do so by law, court order or other legal process, if necessary to enforce any legal right we may have, or if required to do so by our customers to comply with contractual obligations.

#### **Information Collected**

You may visit our site without telling us who you are or providing us with any personally identifiable information. However, we do collect generalized information, such as the number of visits, pages visited and average time spent on the site, in order to improve the information and services available on our site. We can never identify you or your computer system personally from this information. If you send us an e-mail inquiry, we may save your e-mail address to assist us in serving your future needs. However, it is not our practice to send you unsolicited e-mail.

### Cookies

A cookie is a small piece of data that many websites store on the hard drive of your personal computer which can be retrieved as a calling card at a later date to identify the user. We may use a cookie to assist in providing you relevant data and keeping a user logged in if they have requested it. Cookies do not collect personally identifiable information about our users, and your browser can be set to refuse cookies or to notify you before accepting cookies.
